I would propose that the officers of the department are paid a stipend of the above proposal. On top of their Stipends Officers will be paid an hourly rate of 13.80/HR for each call they respond to along with fire department members and payroll will be done once a month. Records will be kept of each call and those responding will be marked down and signed off by the chief.

I also would recommend a training stipend to all members that attend at minimum 40 hours of training in a year. I would recommend a stipend of \$500.00 to all members attending at least 40 hours of training. The Asst. Chief will be the training officer for the department and will document and keep record of all trainings and who is in attendance.
