# Emery Pelletier, Road Commissioner

- He used 165 tons of salt last year and he advised that we put in for 200 tons for next year.
- Selectmen said that a contract will be put out to bid for 2024 deadline is 04/28/2023.
- Discussion re: adding salt to the sand that is left from this year and covering it.
- Emery will continue to be the contact person with the salt company.
- Discussion about what to do with the bridge on River Road, as well as the two sections of River Road which need paving:
  - Walter mentioned that probably only one section would be considered due to the budget
