Piscataquis County Manager - Mike Williams

- Discussion about utilizing the sand pit on Old Brownville Rd. in Sebec for Williamsburg, Barnard and possibly for Atkinson.
- Pete Watters' contract is coming up and it can used until then. Mike asked Pete if he could write down when he uses each sand. Pete puts up about 1,100 to 1,500 yards.
- There was some concern about the sand piles being used for the right towns.
- Emery thinks there is room there for the other towns. He and Mike will go to the sand pit and look at it. Emery will come back to the Selectmen and make his recommendations.

Road Commissioner – Emery Pelletier

- The brush cutting on the Hughes Rd should be done
- Met with Jim from DOT about River Rd. indicated that it should be monitored, not repaired yet. There is a need for guardrails on the Milo end. The Town still owns the gated off part of the road. The railroad bridge is narrow and Jim would like to see it cut back, create new banking, jersey barriers, guard rails and make it a one-way road.
- There is a meeting with Jordan from DEP on Ladd Rd. on Thursday. Keith, Jason and the homeowners will be there.

Fire Chief - Mike Harris

- The truck is ready from the garage and it wasn't as much as they though. He'll take the tanker down to be inspected.
- There is a work session tomorrow night at the Fire Station
- Mike turned in the budget, but is not sure about the utilities.
- He says there is no need for a landline phone at the Fire Station
- There is a county wide first responders class coming up need to get licensed thorough the state. He thinks it is a good idea with the ambulance uncertainty.

Walt did go to the Fire Station and suggested they move the compressor closer to the electrical panel. He ran an oversized wire wire back and under the stairway.
