#### Fire Chief - Mike Harris

- Asked 3 contractors to stop in and look at insulating Fire Station they said they would when they have time.
- The FF had live burn training in Milo 2 weeks ago and another one coming up in Oct. 13<sup>th</sup>
- Applied for a Stephen King grant for a boat will know in Feb. 2025
- Met with Jared Golden's rep. and we haven't heard anything back
- The Terry Ferrell Foundation has a first responder vehicle available, Chevy Tahoe and gear
- Fire Truck still hasn't sold, maybe donate to the Dexter voc. school

- Reviewed which companies we use for oil/propane, would like to get them all on one.
